#### 1. SALIENT FEATURES

Operating profit before tax increased by 18% to R3.83 billion, from R3.25 billion in the prior corresponding period.

Headline earnings per share increased by 20% to 2 545 cents per share, from 2 128 cents per share in the prior corresponding period.

Earnings per share increased by 20% to 2 549 cents per share, from 2 122 cents per share in the prior corresponding period.

Dividends per share increased by 20% to 755 cents per share, from 630 cents per share in the prior corresponding period.

#### 2. DIVIDEND DECLARATION

The directors resolved to declare an interim gross dividend of 755 cents (August 2018: 630 cents) per share from income reserves in respect of the six months ended 31 August 2019. The dividend amount, net of South African dividend tax of 20%, is 604 cents (August 2018: 504 cents) per share for those shareholders who are not exempt from dividend tax. The number of ordinary shares in issue at the declaration date is 115 626 991 and the income tax number of the company is 9405376840.
