**Investec plc, Investec Limited****Demerger Update and Acknowledgement of Ninety One's Announcement of Admission to Trading on the London Stock Exchange and the Johannesburg Stock Exchange**

Further to the shareholder circular published by Investec on 29 November 2019 relating to the proposed demerger and public listing of Investec's global asset management business (the "Circular"), the announcement by Investec on 10 February 2020 confirming the results of the General Meetings of Investec and the Court Meeting of Investec plc and the announcement by Investec on 5 March 2020 confirming that the Scheme had been sanctioned by the Court, Investec today announces the completion of the Demerger, which took effect at 7.00 p.m. (London time) on Friday, 13 March 2020.

Investec also acknowledges the announcement made by Ninety One today confirming Ninety One's admission to trading on the LSE and the JSE.
