#### From continuing operations

Revenue decreased by 13% to R22 166 million, from R25 602 million in the prior year.

Operating profit before capital items decreased by 47% to R1 344 million, from R2 527 million in the prior year.

Headline earnings per share ("**HEPS**") decreased by 68% to 14.8 cents per share, from 45.9 cents per share in the prior year.

Earnings per share ("**EPS**") decreased to a loss of 82.5 cents per share, from earnings of 41.4 cents per share in the prior year.

## From continuing and discontinued operations

Revenue decreased by 14% to R22 218 million, from R25 765 million in the prior year.

Operating profit before capital items decreased by 46% to R1 314 million, from R2 445 million in the prior year.

HEPS decreased by 68% to 13.7 cents per share, from 42.9 cents per share in the prior year.

EPS decreased to a loss of 83.3 cents per share, from earnings of 38.3 cents per share in the prior year.

Net asset value per share decreased by 22% to 372 cents per share, from 474 cents per share in the prior year.

The board of directors has decided not to declare a dividend for the current year.
