As is normal practice for a REIT, where investment property comprises a material component of total assets, the auditor's opinion identifies investment property as a key audit matter. The financial statements have been audited by the Company's auditors, PricewaterhouseCoopers Inc., who expressed an unqualified audit opinion thereon. The opinion is available on the Company's website, at the above link.

The financial statements are the same as the preliminary reviewed condensed consolidated financial statements that were published on 30 June 2020, except for a re-classification in terms of international accounting standards of an amount of R618 million from investing activities to financing activities in the statement of cash flows. The amount relates to the acquisition by Vukile of an additional 7.8% interest in Vukile's Spanish subsidiary, Castellana Properties Socimi ("**Castellana**"), in July 2019, from Westbrooke, a minority shareholder in Castellana. The re-classification of this amount was done in terms of IAS 7 *Statement of Cash Flows*, paragraph 42A, which provides that:

"Cash flows arising from changes in ownership interests in a subsidiary that do not result in a loss of control shall be classified as cash flows from **financing activities**..."
