The board of directors of Coronation are satisfied that a reasonable degree of certainty exists that earnings per share ("**EPS**"), headline earnings per share ("**HEPS**") and diluted headline earnings per share ("**DHEPS**") for the year ended 30 September 2020 are expected to increase by between 10% to 20% (34.2 and 68.4 cents per share) when compared to the EPS, HEPS and DHEPS of 341.9 cents reported for the year ended 30 September 2019 ("**prior year**").

Included in these earnings is the net impact of unrealised fair value gains of 15.4 cents per share, compared to 5.7 cents per share in the prior year.

The financial information on which this trading statement has been based has not been reviewed and reported on by Coronation's external auditors. Coronation's financial results for the year ended 30 September 2020 will be released on or about 24 November 2020.

He holds a Bachelor of Science Mechanical Engineering degree from the University of Natal, Saks is also a graduate of the University of Cape Town's Graduate School of Business. More recently, he also completed the Advanced Management Programme at the Harvard Business School in Boston.
