SHARE CONSOLIDATION FINALISATION ANNOUNCEMENT

Shareholders are referred to the announcements published on SENS on 24 November 2020 and 13 May 2021 relating to, *inter alia*, the consolidation of the Company's share capital on the basis of 1 share for every 25 existing shares held ("Consolidation") and to the subsequent announcement released by the Company on SENS on 12 January 2021 advising shareholders that the special resolution relating to the Consolidation was passed by the requisite majority of Nutritional Holdings shareholders at the general meeting of the Company on the same date.

Shareholders are reminded that for every 25 shares that they hold, this will reduce to 1 share as per the timelines set out below. The conversion table that was set out in the Section 60 circular is available on the Company's website.

The special resolution has been filed at CIPC on 17 May 2021 reducing the authorised share capital from 25 000 000 000 shares of no par value to 1 000 000 000 shares of no par value.
