DECLARATION OF A DIVIDEND OF 294.05 CENTS PER NON-REDEEMABLE,

The directors of Capitec have approved and declared a preference share dividend of 294.05 cents per share in respect of the six months ending on 31 August 2021. Payment will be effected on Monday, 20 September 2021.

The following information is disclosed in terms of paragraphs 11.17(a)(i) to (ix) and 11.17(c) of the JSE Listings Requirements:

- The cash distribution is a dividend as defined in terms of the Income Tax Act (Act 58 of 1962)
- The South African dividend tax rate is 20%
- The gross dividend amount is 294.05 cents per share
- The dividend amount net of South African dividend tax of 20% is 235.24 cents per share
- Capitec has 578 455 non-redeemable, non-cumulative, non-participating preference shares in issue
- The distribution is made from income reserves
