During 2020 Alviva adopted a Minimum Shareholding Requirement ("MSR") Policy to encourage executives to align executive and shareholder interests. The MSR Policy provides that the executives must build up a target minimum shareholding within five years of the approval date of the policy.

Certain executives have elected to convert a portion of their cash STI into shares towards the fulfilment of their obligations under the MSR Policy. The shares are committed to a holding period and will be held in escrow until 15 November 2024.
