## **CURRENCY CONVERSION TO RAND**

South32 Limited (ASX, LSE, JSE: S32; ADR: SOUY) (South32) announced on 17 February 2022 that the Board resolved to pay an interim dividend of US 8.7 cents per share (fully franked) for the half year ended 31 December 2021. The dividend payment date is 7 April 2022. The US cent currency exchange rate applicable to the dividend payable in South African cents, to shareholders on the South African branch register on the Record Date, is:

The currency exchange rate is the volume weighted average price achieved on foreign exchange trades executed over the period 28 February 2022 to 4 March 2022.

The exchange rate applicable to the South32 dividend being paid in other currencies will be determined over the period 28 February 2022 to 16 March 2022. Details of the currency exchange rates applicable for the dividend will be announced to the relevant stock exchanges.

South 32 shareholders registered on the South African branch register will not be able to dematerialise or rematerialise their shareholdings between 9 March 2022 and 11 March 2022 (both dates inclusive), nor will transfers to or from the South African branch register be permitted between 3 March 2022 and 11 March 2022 (both dates inclusive).

- 1. South African dividend tax of 26.67855 South African cents per ordinary share will be withheld from the amount of the gross interim dividend of 133.39275 South African cents per ordinary share paid to shareholders on the South African branch register at the rate of 20% unless a shareholder qualifies for an exemption.
- 2. After the South African dividend tax has been withheld, the net dividend will be 106.71420 South African cents per ordinary share.
- 3. Australia is the country of source of income, the dividend is regarded as 'foreign' for the purposes of South African dividends tax.
- 4. South32 had a total of 4,649,930,753 ordinary shares on issue at the dividend determination date of 17 February 2022.
- 5. The dividend will be paid out of retained earnings.
- 6. For the avoidance of doubt, South African dividend tax, and therefore the information provided in this announcement, is of only direct application to shareholders on the South African branch register.
