IMPLATS CONCLUDES FRAMEWORK AGREEMENT WITH THE MINISTER OF TRADE, INDUSTRY AND COMPETITION AND UPDATE ON RBPLAT DIVIDEND

1. INTRODUCTION

- (a) Implats refers to its offer (Offer) to the holders (RBPlat Shareholders) of issued ordinary shares (RBPlat Shares) in Royal Bafokeng Platinum Limited (RBPlat) as set out in Implats' offer circular (Offer Circular) dated 17 January 2022 and to the announcement released on the same day noting the conditions to the Offer.
- (b) RBPlat Shareholders are also referred to the joint announcement by Implats and RBPlat dated 29 April 2022, in which shareholders were notified that the parties had received confirmation that the South African Competition Commission had recommended that the Competition Tribunal should approve the proposed transaction.
- (c) Terms defined in the Offer Circular shall, where used in this announcement, bear the same meaning as ascribed to them in the Offer Circular.

2. CONCLUSION OF A FRAMEWORK AGREEMENT

- (a) Implats is pleased to advise RBPlat Shareholders that it has concluded a Framework Agreement with the Minister of Trade, Industry and Competition in respect of the proposed transaction, which further underscores the significant public interest benefits which arise from the combination. The terms of the agreement, which are subject to Implats obtaining a 50%+1 shareholding in RBPlat, relate to issues such as employment, support for SMMEs and localisation in terms of section 12A(3) of the Competition Act.
- (b) This is in addition to the Competition Commission's recommendation which found that it would be unlikely that the proposed transaction would give rise to any substantial lessening or prevention of competition in any of the relevant markets, and would be likely to result in public interest benefits.
- (c) The successful conclusion of this Framework Agreement is a further positive endorsement by key stakeholders of the proposed transaction and the significant public interest benefits that are expected to flow from it, and follows the

Memorandum of Understanding signed with the National Union of Mineworkers, RBPlat's majority union and support from the host communities.

(d) The proposed transaction described in the Offer Circular remains subject to Competition Tribunal approval, which is the last remaining substantive condition to the Offer. Northam Platinum is the sole party objecting to the proposed transaction before the Competition Tribunal. Shareholders will be updated on further developments.

3. RBPLAT DIVIDEND

- (a) In terms of the Offer Circular, Implats' Offer Consideration Cash may be reduced on a Rand-for-Rand basis for any dividend declared or distribution made by RBPlat prior to the Settlement Date.
- (b) The board of Implats has considered the RBPlat dividend announced on 2 August 2022 and Implats confirms that the Offer Consideration Cash will not be reduced. Accordingly, the cash portion of the Offer Consideration will remain at R90 to be paid by Implats as part of the Offer Consideration for every 1 RBPlat Share acquired pursuant to the Offer.
- (c) Should RBPlat declare a further dividend or make any other distribution to RBPlat Shareholders prior to the Settlement Date, Implats reserves the right to adjust the Offer Consideration on the basis set out in the Circular.

4. RESPONSIBILITY STATEMENT

RBPlat is a public company incorporated in South Africa. The Offer will be made to RBPlat Shareholders in the United States in compliance with the applicable US tender offer rules under the US Securities Exchange Act of 1934, as amended (**US Exchange Act**), including Regulation 14E thereunder, and otherwise in accordance with the requirements of South African law. Accordingly, the Offer will be subject to disclosure and other procedural requirements, including with respect to withdrawal rights, the offer timetable, settlement procedures and timing of payments that are different from those applicable under US domestic tender offer law and practice. The financial information of RBPlat and Implats, including any included in the offer documentation, will not have been prepared in accordance with US GAAP, or derived therefrom, and may therefore differ from, and not be comparable with, financial information of US companies.

The Implats Shares to be issued pursuant to the Offer as part of the Offer Consideration (the Consideration Shares) have not been, and will not be, registered under the US Securities Act of 1933, as amended (the US Securities Act), or under any laws or with any securities regulatory authority of any state, district or other jurisdiction, of the United States, and may only be offered or sold pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the US Securities Act and in compliance with any applicable state and other securities laws.
