CONSOLIDATED UNAUDITED FINANCIAL RESULTS FOR THE SIX-MONTH PERIOD ENDED 30 SEPTEMBER 2022

The Board of Reinet Investments Manager S.A. announces the results of Reinet Investments S.C.A. for the six-month period ended 30 September 2022.

Key financial data

- **Reinet’s net asset value of € 5.4 billion, reflects a compound growth rate of 8.8 per cent per annum in euro terms, since March 2009, including dividends paid**
- **The net asset value at 30 September 2022 reflects a decrease of € 449 million or 7.6 per cent from € 5 890 million at 31 March 2022**
- **Net asset value per share at 30 September 2022: € 29.93 (31 March 2022: € 31.99 (30 September 2021: € 25.95))**
- **Fifth share buyback programme completed with 2.5 million ordinary shares repurchased for a consideration of some € 49 million, plus transaction costs**
- **Commitments totalling € 53 million in respect of new and existing investments were made during the period, with a total of € 79 million funded**
- **Dividends from British American Tobacco during the period amounted to € 61 million**
- **Reinet dividend of some € 51 million, or € 0.28 per share, paid during the period, an increase of 12% over prior year (September 2021: € 0.25 per share)**

It is governed by the Luxembourg law on securitisation and in this capacity allows its shareholders to participate indirectly in the portfolio of assets held by its wholly-owned subsidiary Reinet Fund S.C.A., F.I.S. (‘Reinet Fund’), a specialised investment fund also incorporated in Luxembourg. The Company’s ordinary shares are listed on the Luxembourg Stock Exchange, Euronext Amsterdam and the Johannesburg Stock Exchange, the listing on the Johannesburg Stock Exchange is a secondary listing. The Company’s ordinary shares are included in the ‘LuxX’ index of the principal shares traded on the Luxembourg Stock Exchange. The Company and Reinet Fund together with Reinet Fund’s subsidiaries are referred to as ‘Reinet’.
