As previously announced, these securities were pledged as security for portfolio debt from an institutional lender. A portion of the debt has fallen due and the Dovie Trust has elected to sell the securities as part of its portfolio rebalancing and debt reduction goals. Post this transaction, 2 349 882 securities remain pledged, against less than R10 000 000 of debt outstanding.

All disposals of Transaction Capital securities were executed on market by a broker, with prior clearance, on behalf of the Director.
