Shareholders of the Company ("**Shareholders**") are referred to Wesizwe's reviewed provisional condensed consolidated financial results for the year ended 31 December 2022 published on SENS on 31 March 2022 ("**Reviewed Results**") and are hereby advised that Wesizwe's audited consolidated annual financial statements for the year ended 31 December 2022 ("**Annual Financial Statements**") are now available on the Company's website.

The Annual Financial Statements have been audited by SizweNtsalubaGobodo Grant Thornton Inc., who expressed an unmodified audit opinion thereon. The audit opinion also includes communication of key audit matters.

The Annual Financial Statements contain no modifications from the Reviewed Results, save for those outlined in the below table. These changes arose during the finalization of the audit and resulted in a change to the Statement of Financial Position, which in turn impacted the Statement of Changes in Equity. There is no impact on the Statement of Profit or Loss and Other Comprehensive Income or the Statement of Cash Flows.

The reclassification arose due to the following:

Shareholder loan 2 was initially recognized at fair value at inception in the financial year ended 31 December 2021 in accordance with IFRS. During the financial year ended 31 December 2022, Wesizwe Platinum Limited ("**the Company**") obtained additional loans from the majority shareholder. The Company conducted a similar fair valuation exercise on the

additional loans together with Shareholder loan 2. Given that this exercise was performed on different timelines, and possibly, different assumptions, a different market interest rate was derived, and consequently a different fair value, for Shareholder loan 2. In this regard, the Company made an adjustment in the Reviewed Results published on 31 March 2023.

Subsequent to the release of the Reviewed Results, and upon further consultation, the Company established that the adjustment to Shareholder loan 2 was not required. The Company has corrected the Shareholder loan 2 fair value that was reported in the Reviewed Results and reclassified same.

Shareholders are further advised that Wesizwe's Integrated Annual Report ("Integrated Report"), incorporating the abridged consolidated annual financial statements of the Group for the year ended 31 December 2022 ("Abridged Financial Statements") and the notice of the Annual General Meeting of the Company ("Notice of AGM"), was dispatched to Shareholders today, 28 April 2023.
