The record date for the posting of the Notice of Annual General Meeting is Friday, 23 June 2023.

The record date on which shareholders of the Company must be registered as such in the Company's securities register in order to attend, participate and vote at the AGM is Friday, 18 August 2023. The last day to trade in the Company's securities in order to be eligible to vote at the AGM will be Tuesday, 15 August 2023.
