African Media Entertainment Limited, a broadcast company listed in the Media and Entertainment sector of the Johannesburg Stock Exchange, with a radio footprint across central South Africa and the Eastern Cape, has pleasure in releasing its results for the six months ended 30 September 2023.

During the period under review, the group was able to improve its performance in comparison to the comparative reporting period ended 30 September 2022 which was mainly driven by the renewed revenue initiatives implemented and growth in market share.

For the period ending 30 September 2023, group revenue increased by 11% to R143.1 million from R128.4 million.

As a result, operating profit improved by 34% to R19.5 million from R14.6 million in September 2022.

An unchanged interim dividend of 100 cents per share has been declared (Interim 2022: 100 cents gross).

### Declaration of interim dividend no 21

The board resolved to declare a dividend (dividend no.21) of 100 cents per ordinary share (gross) for the interim period ended 30 September 2023.

The dividend is subject to the Dividends Withholding Tax ("DWT") that was introduced with effect from 1 April 2012.

In accordance with the provisions of the JSE Listings Requirements the following additional information is disclosed:

- \* the dividend has been declared out of current profits available for distribution;
- \* the local Dividend Tax rate is 20%;
- \* the gross dividend amount is 100 cents per ordinary share for shareholders exempt from DWT;
- \* the net dividend amount is 80 cents per share for shareholders liable for DWT;
- \* the company has 7 022 177 ordinary shares in issue ; and
- \* the company's income tax reference number is 9100/169/71/4.
