AB InBev reports on the progress of its share buy-back program announced on 31 October 2023

Regulated information¹

February 19, 2024 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) ("AB InBev") ("the Company") hereby discloses certain information in relation to its share buy-back program announced on 31 October 2023, in accordance with article 8:4 of the Royal Decree of 29 April 2019 implementing the Belgian Code on Companies and Associations. Under this program, AB InBev has granted a discretionary mandate to an independent financial intermediary to repurchase AB InBev shares for an amount of 1 billion USD² during a 12-month period.

Further to the launch of the share buy-back program announced on 31 October 2023, AB InBev reports the purchase of 562,205 AB InBev shares in the central order book of Euronext Brussels in the period from 12-Feb-2024 up to and including 16-Feb-2024. The shares were repurchased at an average price of 58.5738 EUR per share for a total consideration of 32,930,487.31 EUR.

Since the start of the share buy-back program on 13 November 2023, AB InBev has bought back 13,591,355 shares for a total amount of 786,799,848.88 EUR (856,683,401.09 USD) under the share buy-back program. This corresponds to 0.67% of the total shares outstanding.
