## **DEALINGS IN SECURITIES BY EXECUTIVE DIRECTORS**

In compliance with paragraphs 3.63 to 3.66 of the JSE Listings Requirements, the following information is disclosed in respect of ordinary share dealings by the executive directors.

In October 2015, the Stor-Age Share Purchase and Option Scheme (the "Scheme") was approved and adopted. The purpose of the Scheme was to create ownership opportunities for the executive directors and selected employees whereby they were offered the opportunity to acquire Stor-Age shares (the "Scheme Shares") by way of an interest-bearing loan. Dividends received on the Scheme Shares were applied against the interest payable on the loan. The maximum period for the repayment of the loans was ten years from the date of issue. The Scheme was superseded by a Conditional Share Plan adopted by shareholders in February 2019.

The executive directors have sought an orderly exit from the Scheme by disposing of Scheme Shares from time-to-time to settle their loan obligations owing to the Company. For various reasons, certain shareholders of the Company have expressed a preference for the Scheme to be closed in its entirety and the loan obligations settled in full. In line with this, an institutional shareholder of the Company made an offer to acquire shares held by the executive directors which would achieve this objective.

Of the total shares sold, 6 451 624 related to Scheme Shares. The proceeds from the sale are to be used to settle the outstanding loan obligations owing to Stor-Age in terms of the Scheme. Following the sale, the executive directors will henceforth no longer hold any Scheme Shares.
