- 1. In the ordinary course of business, Investec Bank Limited purchases in the open market listed debt instruments issued by Investec plc to support client trading activities. A position of £52 million was identified that had to be eliminated at an Investec DLC level.
- 2. The Investec Group consolidates securitisation vehicles. The cash held by the vehicles was separately accounted for in the Investec Group on consolidation as 'customer accounts (deposits)' with the corresponding entry in 'other securitised assets'. The accounting treatment was revised and an amount of £72 million was adjusted downwards on each line.
- 3. As part of a balance sheet simplification process, 'Insurance liabilities, including unit-linked liabilities' of £16 million has been aggregated with 'Liabilities to customers under investment contracts'.
