### **RESULTS FOR THE YEAR ENDED JUNE 30 2024**

Bidcorp delivered an excellent performance for the year ended June 2024, against the backdrop of a turbulent and challenging world, beset with anaemic, stagnant, and sometimes negative economic growth.

#### **Financial highlights:**

- Revenue R225,9 billion, up 15,1% (F2023: R196,3 billion)
- Trading profit R12,2 billion, up 15,9% (F2023: R10,5 billion)
- Cash generated by operations before working capital R15,4 billion, up 12,8% (F2023: R13,7 billion)
- EBITDA (non-IFRS 16) R13,5 billion, up 14,4% (F2023: R11,8 billion)
- Strong cash generation 113% of trading profit and 102% of EBITDA turned into cash
- Headline earnings per share 2 405,5 cents, up 15,5% (F2023: 2 082,9 cents)
- Earnings per share 2 392,6 cents, up 16,0% (F2023: 2 061,8 cents)
- Dividend distribution for the full year 1 090,0 cents, up 16,0% (F2023: 940,0 cents)
