## 1. Distribution of Circular and notice of GM

MTN shareholders (Shareholders) are referred to the Company's joint announcement with MTNZF, released on the Stock Exchange News Services of the JSE Limited (SENS) on Monday, 19 August 2024 and published in the press on Tuesday, 20 August 2024, relating to the proposed extension of the scheduled maturity date of the Scheme by three years, from 23 November 2024 to 23 November 2027, and future specific repurchases by MTN of MTN shares from MTNZF on an unwind of the extended Scheme (Transaction).
