- Headline earnings per share decreased by 85.4% to 60.1 cents (2023: 412.6 cents)
- Net asset value per share decreased by 0.5% to R18.78 (2023: R18.88)
- Ordinary dividend per share paid amounted to nil cents (2023: nil cents)
