### Results of Dividend Reinvestment Plan – 2025 Interim Dividend

On 18 February 2025, the Board of BHP determined to pay an interim dividend of 50 US cents per share for the half year ended 31 December 2024. As announced on 18 February 2025, BHP's Dividend Reinvestment Plan (DRP) operated in respect of the 2025 interim dividend. Eligible shareholders who elected to participate in the DRP have now been allocated shares. The DRP Allocation Price was calculated for each jurisdiction as an average of the price paid for all shares actually purchased to satisfy DRP elections.
